RESOLUTION
Of
BOARD OF COMMISSIONERS

JASPER COUNTY, GEORGIA

WHEREAS, Jasper County is paying an annual supplement of \$20,000.00 for the salary of the Chief Magistrate; and

WHEREAS, Jasper County started budgeting said amount after a request by Chief Magistrate Kenneth G. Jackson by letter dated August 12, 2002; and

WHEREAS, Chief Magistrate Kenneth G. Jackson requested in said letter the following: "...that the Jasper County Board of Commissioners supplement my annual salary pursuant to Official Code of Georgia Annotated 15 10 23(d) in the amount of \$20,000."; and

WHEREAS, the Jasper County Commissioners have added said \$20,000.00 Supplement to the County Budget in years since said request; and

WHEREAS, no Local Legislation and no formal ordinance was adopted to authorize said supplement other than the action of including it in the county budget; and

WHEREAS, the Chief Magistrate now receives a very good salary for his position and duties as provided by law; and

WHEREAS, the Chief Magistrate does not work fulltime and does engage in other income producing activities, including the practice of law; and

WHEREAS, the Chief Magistrate position stands for election in calendar year 2008; and

WHEREAS, the Jasper County Commissioners have determined that said supplement is not necessary or warranted to attract qualified candidates for said position; and

WHEREAS, the Jasper County Commissioners have decided to discontinue said \$20,000.00 Supplement at the end of calendar year 2008;

NOW, THEREFORE, BE IT RESOLVED by the Jasper County Board of Commissioners does hereby terminate the annual supplement of \$20,000.00 for the position of Chief Magistrate of Jasper County, Georgia, effective at the end of calendar year 2008.

BE IT FURTHER RESOLVED that county staff is directed to proceed to implement this action and to notify the Chief Magistrate and run a notice of same in the Monticello News, the Official Organ of Jasper County, Georgia.
